### **EDUCATION**

### **NEWS IN EDUCATION**

School is just around the corner! Here is what we do know at this point about Covid-19 requirements for students in Quebec and Ontario, which are quite similar. Every school will share information and ensure that students follow their required guidelines. Restrictions for education staff will be mandated by each province and are stricter than those for students. Please be advised that these restrictions could change if there is an outbreak or if conditions deteriorate in either province. We will keep you notified.

- Masks will be provided and must be worn on buses in both provinces, except for children in JK (Quebec) or JK/SK (Ontario), or for children with disabilities who cannot wear a mask
- > Students will be assigned seats on buses, with children from the same family or grade seated together whenever possible, and a record of the seating plan kept for contact tracing purposes
- If possible, a seat is to be kept empty directly behind the bus driver
- Buses will continue to be cleaned and sanitized thoroughly after each run

### **➢ QUEBEC & KIWETIN:**

- No physical distancing required or restrictions on groupings
- Masks required in cafeteria but can be removed to eat/drink
- Masks required in hallways or when circulating throughout school, but not required in classrooms, for sports, or for outdoors
- O KIWETIN:
  - High touch surfaces will continue to be cleaned and sanitized thoroughly throughout the day

### > ONTARIO:

- Physical distancing promoted as much as possible
- Masks can be removed for eating/drinking or low-contact physical activity (sports)
- Masks required in hallways and classrooms, but not required outdoors
- o TDSS:
  - 2 courses per day for fall semester
  - 20 hours community involvement requirement only for graduates of 2021-2022 school year

### As cited in the TFN Housing By-Law, the following are reminders:

### 3.3.1 Restrictions

2. No tenant shall modify the rental unit it is occupying, except changes resulting from aging or fair wear and tear of the rental unit or superior force. In the event a tenant does so, he will be required, if the TFN Housing Representative deems it necessary, to bring the rental unit back to its original condition.

### 3.3.2 Residential Purpose

1. The tenant shall use the rental unit for residential purposes only. No trade or business shall be carried on in the rental unit or the premises without the prior written approval of the TFN Housing Representative.

### 3.5.3 Maintenance of Rental Unit

2. Every tenant is responsible for the repair of any damages to the rental unit caused by the willful or negligent conduct of the tenant or any person who is permitted on the premises by the tenant. These repairs must bring the unit to the original state of repair and be done in accordance with Industry Standards.

### 3.5.5 Repair Damages

2. No tenant shall remove from a rental unit any fixtures, sinks, bathtubs, or appliances, and shall not alter, make additions to or affix any item, fixture or thing to the floors. Exterior or interior walls, roof (satellite dishes) or ceiling of the rental unit without the prior written consent of the TFN Housing Representative.

### 3.5.7 Cleanliness and Overcrowding

1. Every tenant shall maintain the rental unit in a state of ordinary cleanliness. Every tenant shall maintain the land surrounding the rental unit in a good and clean condition and shall be responsible for yard maintenance, including cutting grass, raking leaves and proper garbage disposal. Every tenant shall maintain a healthy and safe environment; by disposing of any abandoned vehicles, any scrap metal, tir3es, chemical waste and any other debris around the yard.







# Making a request under Jordan's Principle Orthodontic treatment

# BEFORE YOU START

It is possible to submit a request for orthodontic treatment under Jordan's Principle.

Before submitting a request for orthodontic treatment, you must first have made a request under the Non-Insured Health Benefits (NIHB) Program for orthodontic services.

To submit a request under the NIHB program, go to: the website of Indigenous Services Canada. The child must be under 18 years old.



### JORDAN'S PRINCIPLE TEAM WILL AGREE TO ANALYZE A REQUEST FOR ORTHODONTIC TREATMENT UNDER TWO CONDITIONS:

- 1 Denial of the NIHB Program for treatment coverage.
- Proof of substantive equality.



### CONCEPT OF SUBSTANTIVE EQUALITY

Substantive equality is a legal principle that recognizes that not all children have the same life context, which may cause them to have more needs. Sometimes, the situation of certain children requires more services to ensure that their needs are met and that the outcomes are comparable to those of other children in the population. It is therefore important for the care, products or services to be adapted to allow First Nations children to benefit from additional help when necessary so that they receive adequate services.

To fully explain and describe substantive equality in your request, you can use the demonstration of substantive equality form in the Jordan's Principle toolkit.



### HERE ARE THE DOCUMENTS TO ATTACH TO YOUR REQUEST:



### 1 Jordan's Principle request form

Certain sections of the request form are sometimes complex. It is recommended that you complete it as best you can, while taking care to include as much details as possible. If any information is missing, the Jordan's Principle team will contact the requester.



TIP: It is vital to ensure that the Indigenous Services Canada agent who will analyze the request fully understands the situation of the child. It is therefore very important to properly describe the need and to provide as much information and details as possible to flesh out the request. For example, you can mention the positive effects of the requested service as well as the foreseeable negative effects if the request is denied. If you are short on space, details and clarifications can be outlined in a letter that you can attach to the form when submitting the request.

### 2 Demonstration of substantive equality

Use the demonstration of substantive equality sheet in the Jordan's Principle toolkit.



or

Write a letter highlighting elements of the socio-economic, family, personal, historical or other contexts having an
impact on the reason for the request (need of the child, family, community or organization).







### Contact information

- The full name, civic address and email address of the parent or guardian or Jordan's Principle Coordinator, as applicable. You can add this information in the request form or enter it directly in the email when sending the documents.
- This information is necessary to send the approval or denial letter or to request additional information.

### ADDITIONAL INFORMATION

If the child is being bullied because of their teeth or if their self-esteem or mental health is affected, these criteria may be considered as part of the request. The situation must be clearly described in the individual request form.

It will be important to include a note from a professional who noted the bullying to which the child is subjected. For example: a childcare services educator, teacher, supervisor, social worker, etc.

When the file is complete, a decision can be provided within 48 hours. However, the request may be sent to Ottawa for further analysis. A much longer period should then be considered (from a few weeks to a few months).

# My Records, My Choice The Indian Residential Schools Settlement Agreement lets claimants preserve their IAP or ADR records at the National Centre for Truth and Reconciliation (NCTR).

# INDIAN RESIDENTIAL SCHOOL CLAIMANTS MAY CHOOSE TO SHARE THEIR RECORDS OR KEEP THEM CONFIDENTIAL

If you made a claim in the Indian Residential Schools Independent Assessment Process (IAP) or Alternate Dispute Resolution Process (ADR), you have choices:

- Do nothing: your records will remain confidential and then will be destroyed on September 19, 2027
- Get a copy for yourself to keep or share with others
- Preserve your records at the NCTR for history, education and research
- Get a copy for yourself <u>and also</u> preserve your records at the NCTR for history, education and research

# Call for Board of Directors (3 seats) Widjikiwe Holdings Corp.

WIDJIKIWE HOLDINGS CORP. The Role of Widjikiwe Holdings Corp. is to improve the overall well-being and self-sufficiency of the community through the creation of new economic development opportunities that will provide long lasting, well remunerated and challenging jobs for community members. The mission of Widjikiwe can be summarized as follows:

- A. Oversee businesses under Widjikiwe Holdings Corp.; such as TFN Construction LP and Widjikiwe Gas Bar LP
- B. Create and invest, in partnerships with members and non-members of the TFN community, in the start-up and management of new businesses;
- C. Create in collaboration with TFN Economic Development Director and enabling environment to develop local entrepreneurship.

The mandate is wide but could be shortened by the following sentence "establish new business investments (wholly owned, joint ventures and minority equity investments) that meet the investment criteria and maximize both quality employment opportunities and return on investment"
